

PITTSBURGH METALS ASBESTOS SETTLEMENT TRUST

NOTICE OF DEADLINE REQUIRING FILING OF CLAIM FORM AND DECLARATION ON OR BEFORE OCTOBER 31, 2012 PLEASE TAKE NOTICE THAT:

Michael F. Rooney, the Trustee of the Pittsburgh Metals Asbestos Settlement Trust, with the consent of the Trust Advisory Committee (the "TAC") has established **4:00 p.m. (prevailing Eastern Time) on October 31, 2012** (the "Cancer Bar Date") as the last date for each person or entity to file a Claim Form and Declaration against the Pittsburgh Metals Asbestos Settlement Trust (the "Trust").

1. WHO MUST FILE

You **MUST** file a completed Claim Form and Declaration, as specified in the Trust Distribution Procedures for Pittsburgh Metals Asbestos Settlement Trust (the "TDP"), and as further explained by the Instructions for Filing a Claim with Pittsburgh Metals Asbestos Settlement Trust (the "Instructions"), if you wish to assert a Level II, Level III or Level IV Asbestos PI Claim against the Trust. Pursuant to the Second Amended Plan of Reorganization for Treesdale, Inc. an Pittsburgh Metals Purifying Company, Inc., as amended (the "Plan"), an Asbestos PI Claim is defined as any claim against a Debtor (i) that alleges liability for bodily, personal or emotional injury or death allegedly caused by exposure to any asbestos or asbestos-containing materials, but only to the extent such liability is based on or derives from injury allegedly caused, in whole or in part, by materials installed, sold, handled, used, made, distributed, supplied, removed or otherwise distributed by that Debtor or for which that Debtor otherwise allegedly was responsible, and (ii) which was unliquidated as of the Petition Date.

You **MUST** file a completed Claim Form and Declaration if you have a settled Asbestos PI Claim that has not been paid in full. For purposes of the Cancer Bar Date, claimants holding a St. Paul Settled Claim who elect not to accept his/her pro rata share of the proceeds from the St. Paul settlement as payment in full for his/her claim must file a Claim Form and Declaration.

2. WHAT TO FILE

You **MUST** file a completed Claim Form and Declaration, which is attached hereto as Exhibit A. All Claim Forms and Declarations must be **signed** by the Injured Party, his/her Attorney or a Personal Representative. It must be written in English. You must attach to your completed Claim Form and Declaration any documents which are required to be attached by the Claim Form and Declaration, and the Instructions related thereto.

3. WHEN AND WHERE TO FILE

A Claim Form and Declaration must be filed so as to be actually received at the following address **on or before 4:00 p.m. (prevailing Eastern Time) on October 31, 2012:**

Claim Forms and Declarations will be deemed timely filed only when received by MFR Claims Processing, Inc. as described herein on or before 4:00 p.m. (prevailing Eastern Time) on the Cancer Bar Date. Claim Forms and Declarations may not be delivered by facsimile or telecopy.

4. ~~WHO NEED NOT FILE~~

You do **not** need to file a Claim Form and Declaration: (a) if you have a Level I Asbestos PI Claim or (b) if you hold a St. Paul Settled Claim (as defined in the Plan) and will accept your pro rata share of the proceeds from the St. Paul settlement as payment in full for your claim.

5. ~~CONSEQUENCE OF FAILURE TO TIMELY FILE~~

ANY PERSON OR ENTITY (EXCEPT A PERSON OR ENTITY WHO IS EXCUSED AS SET FORTH IN SECTION 4 ABOVE) WHO FAILS TO FILE A CLAIM FORM AND DECLARATION ON OR BEFORE THE CANCER BAR DATE SHALL BE FOREVER BARRED AND ESTOPPED FROM ASSERTING SUCH CLAIM AGAINST THE TRUST AND RECEIVING A DISTRIBUTION FROM THE TRUST IN RESPECT OF SUCH CLAIM.

A HOLDER OF AN ALLEGED ASBESTOS PI CLAIM AGAINST THE TRUST SHOULD CONSULT AN ATTORNEY REGARDING ANY MATTERS COVERED BY THIS NOTICE, SUCH AS WHETHER THE HOLDER SHOULD FILE A CLAIM FORM AND DECLARATION.
